- B. Farm agrees to provide normal and reasonable care to maintain the health of said horse(s). The option of the basic fee includes the following and can be changed at any time the stable receives notice from the owner/lessee.
1. Stabling, exercising and daily turnout.
 2. Blanketing (owner furnishes).
 3. Daily grooming.
 4. Supplements, grain and hay.
 5. Daily wormer.
 6. Training at whatever level, monitored by age, size and sex and according to owners purpose.
- C. The following will be paid for by owner/lessee:
1. Farrier (once per month or as needed).
 2. Regular vaccination – every three to four months, if being shown. Twice yearly all others.
 3. All show entry fees, stall fees, bedding.
 4. All show fees and show expenses billed by Training Facility (see attached schedule). Laundering/repair fees for blankets/sweats/hoods.
 5. All veterinarian expenses incurred by your horse. This includes, but not limited to coggins, brand inspection, and health certificate as required by government.

D. Trainers responsibility:

Trainer, Cindy Kanzler, shall fulfill the duties in the manner consistent with good equine show-training practices in the County of King, the State of Washington, and will show at shows as per show schedule put out at the beginning of the year.

E. Ownership:

Owner warrants that he/she owns the horse or is said lessee, and will provide proof (copy of both sides of registration papers, or bill of sale) at the time of delivery and proof of updated vaccinations.

F. Emergency:

In an emergency, every effort will be made to contact owner prior to vet arriving, but in the event of emergency and the owner cannot be reached, stable or trainer has the authority to secure an emergency vet.
